MANAGER'S REPORT:

- Borough Manager, Roger Nuss read a summary report of the Borough employee activities for the month of March.

WATER

- Water Authority Superintendent Cindy Bachman reported the state issued a voluntary reduction in water usage due to drought.
- Monday, May 4, 2015 fire hydrants will be flushed.
- Saturday, April 25, 2015 there will be a drug take back at the police station.
- April bills will be enclosed in an envelope with the annual water quality report.

CODE ENFORCEMENT:
