ORDINANCE 2005 - 07

AN ORDINANCE OF CATAWISSA BOROUGH AUTHORIZING CERTAIN CHANGES TO CATAWISSA ORDINANCE CHAPTER 8, ELECTRICITY, PART 1 AND PART 2

WHEREAS, the Council of the Borough of Catawissa is authorized to adopt ordinances providing for electric service regulations and collection of electric service charges; and

WHEREAS, the Council of the Borough of Catawissa deems it to be in the best interest and welfare of the residents of the Borough of Catawissa to make certain changes to Catawissa Ordinance Chapter 8, Electricity, Part 1 and Part 2.

NOW, THEREFORE, IT IS ORDAINED AND ENACTED by the Council of the Borough of Catawissa, Columbia County, Pennsylvania, as follows:

- 1. Chapter 8, Part 1, Section 102, Rate Classifications is hereby deleted.
- 2. Chapter 8, Part 2, Section 202, Schedule for CD-Community Service is hereby deleted.
- 3. Chapter 8, Part 2, Section 203, Schedule GS-General Service is hereby deleted.
- 4. Chapter 8 is hereby amended to include Section 205 which shall read as follows:

Section 205. Purchased Power Adjustment Clause (PPAC). The Purchased Power Adjustment Clause, PPAC, recovers variations in the total cost of power supply not included in the base rates. The total cost of power is the sum of fixed and variable costs, fuels, interchange, transmission and any applicable distribution charges. There shall be added or subtracted from each monthly bill, for each

rate class, an amount equal to the total KWH billed during the month multiplied by the PPAC. Costs or reductions passed through the PPAC are actual costs or reductions incurred. Periodic changes will be made to the PPAC to insure that power costs are equitably recovered from the rates.

The base purchased power cost will be set by resolution yearly. It will be periodically reviewed and revised, if necessary.

Each monthly bill may include a positive or negative Purchased Power Adjustment Clause Factor to reflect the changes in the actual purchased power cost.

The PPAC shall be applied to each kilowatt-hour (KWH) supplied under all rate schedules. This adjustment determined to the nearest 0.01 mill in accordance with the formula set forth below shall be applied to all kilowatt-hours supplied during the billing period.

 $A = (C-B) \times (D/E)$

A = The amount of purchased power adjustment per kilowatt-hour to be applied to all bills.

C = The total current cost of power purchased from the Borough's power suppliers determined by dividing the total cost of power, including all costs, by the kilowatt hours purchased during the first preceding calendar month prior to the billing date.

B = Base purchased power cost, set by resolution.

D = Total kilowatt-hours purchased by the Borough from all power suppliers for the 12 preceding months.

E = Total kilowatt-hours sold by the Borough for the 12 proceeding calendar months.

 All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
