# CATAWISSA BOROUGH COUNCIL MEETING MONDAY June 7th, 2021 - 6:30 p.m.

#### CALL TO ORDER:

• The meeting was called to order by Council President, Doug Krum.

#### ROLL CALL:

• Present were: Doug Krum, AJ McKenney, Victoria Waugh, Roy Klinger, Attorney Anthony McDonald, Mayor Todd Burke Absent: Corey Yule, Jamie Cotner, Janel Patel

#### **READING OF MINUTES:**

 A motion was made by Victoria Waugh, 2<sup>nd</sup> by Roy Klinger to dispense reading of and approve minutes of the previous month's meeting. All Aye

## **GUESTS TO BE HEARD:**

- Guest Pastor Mike Spagnuolo read a prepared letter that was distributed to Council regarding the intended purpose of vacating Bank Avenue and the use of the church parking lot. Pastor Spagnuolo asked that these things be considered, Bank Avenue be vacated and returned to Catawissa Christian Church and to clarify that all business and all residents can and has been allowed to use the church parking lot.
- Guest George Fletcher spoke of the culvert project and a drain that was place on the United First Methodist
  Church property. Mr. Fletcher is concerned with a sink hole that keeps opening up and asked for a resolution.
  Attorney Anthony McDonald is going to look at the bid bond for the contractor to see if the Borough can have
  them return to do some work.
- Guest Vito Clemente spoke at length of fair and equal treatment of all businesses and looking out for the best
  interest of the whole community. Mr. Clemente also spoke of fair treatment regarding the use of Fox Avenue
  and Bank Avenue or to go back to pre-pandemic conditions. Mr. Clemente feels his parents are being targeted
  due to the fact of being asked to remove their picnic tables daily in case of a fire and fire trucks needing to enter
  on Fox Avenue. Mr. Clemente pointed out other points of entry fire trucks can use to enter the alley way behind
  Vito's.
- Guest Cindy Bachman asked if she could speak of (2) agenda items already on the agenda under her report. Council President Doug Krum stated that would be fine.
- Guest Pat Hess inquired about the Office Staff's salary and if the raises on the agenda was because they took on more work. Ms. Hess asked what was the office staff currently making. Council President stated Connie is \$19.67/hr and Nancy is \$22.50/hr. Ms. Hess also inquired what if the new council wants to hire a new Borough Manager. Council President Doug Krum replied he has no say in that. Ms. Hess asked what happens to the \$3.50 when those duties fall to the way side. Council President Doug Krum said that is not up to him because he will not be on Council.

# CORRESPONDENCE:

 Borough Secretary Connie Cole reported the Borough received a call from Deb Dombroski with the Senior Center thanking Public Works Employees Chase Petty and Tyler Torres for the wonderful job they did installing the new kitchen sink.

## MAYOR:

- Mayor Todd Burke thanked everyone for coming to the meeting.
- Mr. Burke shared a story of Corporal Hayes helping an elderly woman who had no one she trusted to come into her home and help her with an air conditioner and put together a fan on a day the temperatures were high.

## WATER:

- Water Authority Superintendent Cindy Bachman asked if demolishing the property at 104 Main St is the last
  course of action that can be taken. Ms. Bachman expressed her concerns on losing another property. Attorney
  Anthony McDonald explained what it would take to have a property condemned and options the Borough could
  take for the property to be demolished. Ms. Bachman asked if the property was demolished could something
  else be built there. Attorney McDonald stated generally speaking no because it is in a flood zone.
- Ms. Bachman asked if the funds that are going to the Cemetery Project could be used to take care of the dry hydrant. Council President Doug Krum informed Ms. Bachman the funds are coming from the Eyer Fund so, no they cannot.
- Ms. Bachman reported she attended a meeting with Fire Chief Dale Hendricks, Council President Doug Krum, Jason Fitzgerald with Penn Strategies and Public Works Employee Crystal Stoker concerning the dry hydrant. There was supposed to be a follow up phone conversation but it never happened. Ms. Bachman stated with the new dry hydrant location the opening of the pipe must be constantly maintained. Ms. Bachman explained the process they must go through to maintain that opening and stated it is not practical. Ms. Bachman requested someone reach out to Mr. Fitzgerald to see if the dry hydrant can be repaired with the funds remaining from the grant. Council President Doug Krum stated he would reach out to Mr. Fitzgerald.
- Ms. Bachman stated the Water Authority provides water at the Cara Park bathrooms as a courtesy for bathroom use only. Ms. Bachman shared a story of a Pavilion Renter who asked permission for a slip & slide and was told no they could not hook up a hose to the bathroom water. Ms. Bachman went by the pavilion on said Renter's date and found the Renter had hooked up a hose to fill a kiddie pool. Ms. Bachman made a suggestion that a policy be made for the water usage when renting the pavilion.
- Ms. Bachman spoke of Senate Bill 597 regarding PUC regulating sewer & water. Ms. Bachman suggested
  contacting PSAB and requested we look into the bill. Ms. Bachman requested the Borough submit an opposition
  letter to Senator Gordner. Ms. Bachman said it would not serve the community well if the Public Utility
  Commission stepped in.
- Ms. Bachman asked if the Water Authority could use the Sensus Handheld for meter reading since the Borough
  has changed over to tablets. The Water Authority's only handheld is no longer functioning. Council President
  Doug Krum told Ms. Bachman that is fine.

# **CODE ENFORCEMENT REPORT:**

Council President Doug Krum read the code enforcement report.

#### POLICE:

- Chief Laidacker reported for the month of May the department responded to (231) calls for service. Chief Laidacker read his report which stated the following:
- The SUV repairs were completed and the brakes were replaced.
- Repairs to the front axle of the sedan were completed, and recall work was done.
- The SUV received damage when, during an attempt to stop, a suspect rammed into the passenger side. The insurance company has been notified.
- Officers volunteered time to assist with Dumpster Day.

- Corporal Hayes and Officer Krape attended vehicle inspection class.
- Officer McNelis attended a (2) day training in order to become the property/evidence officer.

- Officer McNelis also attended training for De-escalation, CPR Certification, and Search and Seizure training.

## **PUBLIC SAFETY:**

- A motion was made by Victoria Waugh, 2<sup>nd</sup> by AJ McKenney to discuss Vito's moving their picnic tables out of of Fox Avenue at the end of business day. Council President Doug Krum suggested Vito's move picnic tables Sunday through Tuesday. Vito Clemente asked what is the purpose? Don't fires happen every day? Mr. Clemente asked why fire trucks can't enter Kline Avenue by other directions. Mr. Clemente asked why are we going back to this again? Councilwoman Victoria Waugh stated she feels everyone should be treated fairly. Ms. Waugh sees the safety issue and also sees Mr. Clemente's side of being treated fairly. Attorney Anthony McDonald strongly suggests treating people fairly, equally and consistently. Attorney McDonald also suggested having a committee come up with permitting for the alleys. Attorney McDonald explained the code for vacating an alley and stated it is not as easy as giving the alley back for \$1.00. Attorney McDonald said it is not a good look for businesses to feel they are being treated differently which is not a good thing. Attorney McDonald stated he feels a committee needs to be put together to study this. Councilwoman Victoria Waugh asked Attorney McDonald if he had easy access to the laws that can be provided to Council. Attorney McDonald volunteered to sit in on the first meeting. Attorney McDonald made a suggestion to let things the way they are until a committee can be made and a study be done.
- A motion was made Victoria Waugh, 2<sup>nd</sup> AJ McKenney to approve the purchase of a License Plate Reader for \$2,300.00 per year for (5) years. The first year will be paid by the Benevolent Fund, Donation Fund and with funds from the sale of the BCM weapon. All Aye
- A motion to discuss Catawissa Hose Company #1's request for financial support with funds from the American Rescue ACT 2021. No motion was made because funds have to be applied for.

# **UTILITIES:**

• A motion was made by Roy Klinger, 2<sup>nd</sup> by Victoria Waugh to discuss power conservation for Borough Residents. Councilman Roy Klinger explained what peak load times are, what the power conservation with AMP entailed and that the details will be posted on the website and Facebook.

# PROPERTY & BUILDING MAINTENANCE:

- Council President Doug Krum thanked Crystal Stoker, for donating the flowers and planters to help beautify the Borough.
- A motion was made by Roy Klinger, 2<sup>nd</sup> by AJ McKenney to discuss bids for the repair of the Sewer Plant Roof. Council President Doug Krum stated the Borough only received one bid from Stine Construction in the amount of \$4,620.00. A motion was made by Victoria Waugh, 2<sup>nd</sup> by Roy Klinger to accept the bid from Stine Construction for the repairs to the Sewer Plant Roof. All Aye
- A motion was made by Victoria Waugh, 2<sup>nd</sup> by Roy Klinger to discuss Public Works repairing and repainting the back wall of the Community Center that was damaged from water leaching through. The work will be completed on a rainy day. Council President Doug Krum asked Public Works Employee Bob Dunkelberger if this was the wall where you come in the back door. Mr. Dunkelberger replied yes and it will take more than one day. A

- A motion was made by Victoria Waugh, 2<sup>nd</sup> by Roy Klinger to approve raising the rental fee for the Community Center to \$55 plus tax for residents and \$100 plus tax for nonresidents after repairs are complete. All Aye Councilwoman Victoria Waugh informed Council the rental fee is now taxable and that what we currently charge does not cover cleaning and sanitizing. All Aye
- A motion was made by Victoria Waugh, 2<sup>nd</sup> by AJ McKenney to approve submitting an application for Columbia County Blight Remediation and Demolition Program for 104 Main St. 3; Aye, 1; Nay: Roy Klinger. Motion carries

Council President Doug Krum stated he spoke with Treasurer Nancy Yost and she suggested staying with the current coverage. A motion was made by Roy Klinger, 2<sup>nd</sup> by Victoria Waugh to renew the Wright Flood Insurance at the current coverage. All Aye

- A motion was made by Victoria Waugh to discuss a raise in the amount of \$3.50 per hour for Borough Secretary Connie Cole and Borough Treasurer Nancy Yost. Motion dies due to lack of 2<sup>nd</sup>.
- A motion was made by Victoria Waugh, 2<sup>nd</sup> by Roy Klinger to approve hiring Colin Sharrow for the part-time seasonal Public Works position starting June 21, 2021 at rate of \$13/hr no more than 32 hours per week. All Aye

  Attorney Anthony McDonald told Ms. Waugh he would get together with her on this.
- A motion was made by Roy Klinger, 2<sup>nd</sup> by Victoria Waugh to approve T Mobile to install an emergency generator at their existing cellular site located at 221 Fox Ave. All Aye
- A motion was made by AJ McKenney, 2<sup>nd</sup> by Roy Klinger to discuss installation of 25 roof top solar panels at 136 Railroad St. Councilman Roy Klinger stated adequate information was needed. Mr. Klinger also feels enough Councilmembers are not present. Mr. Klinger feels council as a whole should be present for this. Attorney Anthony McDonald suggest having an ordinance done for Wind and Solar Power. A motion was made by Roy Klinger, 2<sup>nd</sup> by AJ McKenney to table the matter until more information can be gathered. All Aye
- A motion was made by AJ McKenney, 2<sup>nd</sup> by Roy Klinger to discuss a plaque for Ben Hollingshead. Council
  President Doug Krum stated the Borough is waiting for Alicia Hollingshead to see what is wanted on the plaque.
  Guest Daniel Johnson suggested the plaque being mounted to a light pole at the square. A motion was made by
  Roy Klinger, 2<sup>nd</sup> by AJ McKenney to approve up to \$1000.00 to purchase a bronze plaque for Ben Hollingshead
  dedication. All Aye
- A motion was made by Roy Klinger, 2<sup>nd</sup> by AJ McKenney to discuss the replacement of the lights on the Bluff. A
  motion was made by Victoria Waugh, 2<sup>nd</sup> by Roy Klinger to approve the install of solar lights at the bluff for the
  quote of \$473.69 with Tyler Torres's solar panel. All Aye

# **NEW BUSINESS:**

Attorney McDonald suggested Council have the Fire Department apply for the appropriate permits but waived the fees. A motion was made by Roy Klinger, 2<sup>nd</sup> by AJ McKenney to approve the Fire Department to apply for the proper permits waiving Catawissa Borough permit fees to put a new roof over the main entrance. All Aye
- A motion was made by Roy Klinger, 2<sup>nd</sup> by AJ McKenney to approve the resignation of Councilwoman Jamie Cotner. All Aye
- A motion was AJ McKenney, 2<sup>nd</sup> by Roy Klinger to approve accepting Letters of Interest for the open Council seat that expires December 31st, 2021. All Aye
