READING OF MINUTES:

 A motion to dispense reading of and approve minutes of the February 6th, 2024 Borough Council Meeting was made by Jeff Fleming, 2nd by Ernie May. All Aye

GUESTS TO BE HEARD:

- Guest Gary Roberts gave a full report on the activities scheduled for the 250th anniversary celebration. The 250th Committee would like to have fireworks. Mr. Roberts asked if there was an ordinance pertaining to fireworks. Mr. Roberts was told yes and he should speak with the Code Enforcement Officer.
- Guest Wayne Levan explained he is trying to purchase a piece of property and put storage units on the property. But the setbacks will not allow this without a variance. Mr. Levan feels it benefits the Borough and it would be in the borough's best interest to change the ordinance. Council has agreed to consult the Borough Solicitor and get back to him.
- Guest Linda Kashner read various mistakes she sees in the Profit & Loss report compared to the budget. Council President Andrew Detwiler invited Ms. Kashner to come to a Finance Committee meeting so her concerns can be discussed.
- Guest Rick Unger inquired if any progress was made having more than one building code inspector. Mr. Unger was informed the Borough Solicitor will need to review the BIU contract the Borough has already signed.
- Guest Cindy Bachman, Water Authority Superintendent inquired about unresolved issues
 with the Borough and the engineer for the Dry Hydrant project. Ms. Bachman made
 Council aware the project needs to be readvertised, so someone needs to keep on it.
