# WATER AUTHORITY:

- Water Authority Superintendent Cindy Bachman reported next month's water bills will come in an envelope with the water quality report. Monday May 5<sup>th</sup> hydrants will be flushed. Ms. Bachman warned everyone not to do laundry that day. Ms. Bachman also reminded everyone the Borough is still in a drought.
- Ms. Bachman requested the motion for the Water Authority truck rental be amended to include utilizing
  parts the borough has on hand and the water authority will replace them. Council agreed.

# POLICE:

- Chief Laidacker read the police report for March 2024. Police responded to 545 calls during the month.
- SUV was taken for repairs on the struts.
- The application for the 2025 Firehouse Grant was not submitted due to the portal only being open for a short period of time because of the many applications received.
- The department is short staffed due to an officer being out on medical leave.
