Staff and Authority Reports

- WATER AUTHORITY:
 - Water Authority Superintendent Cindy Bachman reported the state still has the Borough in a drought and to be mindful of usage.

Committee Reports

- FINANCE/UTILITIES:
 - A motion to approve a pension study at a cost of \$1,850 to review how changing the current pension plan will impact the contribution of the Borough. The study will be paid by the pension plan. A motion to table was made by Ernie May, 2nd by John Mensch until further information can be gathered. All Aye
 - A motion was made by Jeff Fleming, 2nd by Sue Helwig to reimburse Riverview Apartments \$2,009.64 for the 2024 tax overpayment and \$1,644.05 for their 2025 tax overpayment, as per the agreement regarding property value negotiated by the Borough, the School District and the County. All Aye
 - A motion was made by Ernie May, 2nd by Paul Hulse to reject the proposed American Tower rent reduction. All Aye
 - A motion was made by Jeff Fleming, 2nd by Paul Hulse to approve TLM Electric to install power to High Power Boxes for the \$5,125 not paid by the grant for the camera project with funding coming from a \$2,000 donation to the police by the VFW, \$1,625 from Electric GL 442.20 and \$1,500 from Police Professional Services GL 410.35.  19 food vendors, 18 craft vendors, a bounce house, music and bingo. Numidia fire company will be there
