DATE: December 8th, 2025 – 6:30 p.m.

- CALL TO ORDER
 - Meeting called to order by President Andrew Dewiler.
- PLEDGE OF ALLEGIANCE
- ROLL CALL: Andrew Detwiler, Jeff Fleming, Sue Helwig, Kevin Ferris, Ernie May, John Mensch, Paul Hulse and Mayor Todd Burke.
- READING OF MINUTES:
 - A motion to dispense reading of and approve minutes from the November 10th, 2025 meeting was made by Jeff Fleming, 2nd by Sue Helwig. All Aye
 - Council President thanked Councilwoman Sue Helwig for her service on Council for the last 4 years.

 - Treasurer Trish Bauman reported for Water Authority Cindy Bachman the income surveys to determine the CDBG grant eligibility will be mailed out at the beginning of the year.

 - The department is still short-staffed due to an office being out on medical issues.

Councilwoman Sue Helwig stated she feels 2 part-time are better than one 1 full time person.
